**THE UNITED STATES' THIRD STATUS REPORT REGARDING  
FINAL DISTRIBUTION FROM SCBA LIQUIDATION, INC.  
(FORMERLY SECOND CHANCE BODY ARMOR, INC.)  
IN PAYMENT OF THE UNITED STATES' CLAIM**

On August 30, 2012, Plaintiffs, the United States of America and the Relator, Aaron J. Westrick, Ph.D., filed a stipulated dismissal of Defendant Second Chance Body Armor, Inc. (n/k/a SCBA Liquidation, Inc.) (Second Chance) from this action following the distribution of \$3,564,883.84 in partial satisfaction of the United States' May 2011 Amended Proof of Claim in In re SCBA Liquidation Inc. (W.D. Mich. Bankr. No. 04-12515 (JDG)), Dkt. No. 319. This Court entered the dismissal of Second Chance on September 20, 2012. Dkt. No. 321. On September 5, 2013, the United States received a second distribution from the Second Chance Estate in the amount of \$384,429.07 to the United States in further partial satisfaction of its Amended Proof of Claim. Dkt. No. 368. At the time of the September 2013 payment, the United States had been informed that there would be a "small" final distribution which was expected not to exceed \$20,000. *Id.*

On February 6, 2014, the United States received its final distribution from the Second Chance Estate in the amount of \$235,492.90, which exceeded the prior estimate of the final distribution.


The United States received a total of \$4,184,805.81 from the Second Chance Estate.<sup>1</sup>
