ORDER FOR DISBURSEMENT  
UNDER 33 U.S.C. § 1908(a)

This matter came before the Court at the sentencing of Defendant Holy House Shipping AB, on March 10, 2009, upon the applications of Pamposo M. Juanola, Jr. (by his attorney, John F. Renner, Esq.) and of Jimmy Miranda (by his attorney Yaron Helmer, Esq.) for an award pursuant to 33 U.S.C. § 1908(a) in an amount not exceeding one-half of the criminal fine imposed upon sentencing for conviction on Count I herein upon Defendant Holy House Shipping AB; and

The United States, through its attorneys Ralph J. Marra, Jr., Acting U.S. Attorney (by Ronald Chillemi, AUSA) and Garry N. Donner, Trial Attorney, Environmental Crimes Section, U.S. Department of Justice, assenting to the disbursement of environmental whistleblower awards to these two applicants in a total amount not to exceed \$375,000 (which is one-half of the \$750,000 fine imposed on Count I herein); and

The Court having considered the submissions and arguments of counsel and other evidence presented, and having determined, for reasons stated in the Oral Opinion of March 10, 2009 [which Oral Opinion may be augmented by a written Opinion to be filed

shortly], that these applicants have demonstrated an entitlement to awards in the amounts of \$300,000 for Pamposo M. Juanola, Jr., and \$75,000 for Jimmy Miranda, to be paid out of the fine which has been tendered by Defendant Holy House Shipping AB; and

The claimants, Pamposo M. Juanola, Jr. and Jimmy Miranda, having waived their rights to appeal, both orally and in writing, after consulting with their attorneys;

IT IS, this 25th day of **March, 2009**, hereby

ORDERED and ADJUDGED that an award pursuant to 33 U.S.C. § 1908(a) shall be made to Pamposo M. Juanola, Jr. in the amount of Three Hundred Thousand Dollars (\$300,000.00), and which sum the Clerk of Court shall forthwith disburse to Mr. Juanola and his attorney as follows:
