This term consists of FOUR (4) YEARS of Probation, as to Count 1 of the Information.

SPECIAL CONDITIONS OF PROBATION

- 1. As set forth in the Plea Agreement, Bernhard Schulte Shipmanagement (Singapore) Pte Ltd. must pay a fine of \$1,750,000.00 within Thirty (30) Days of entry of the Court's Final Judgment.
- 2. During the term of Probation, Bernhard Schulte Shipmanagement (Singapore) Pte Ltd. must implement and pay for the Environmental Compliance Plan described in the thirty-one (31) page Attachment A to the Plea Agreement.
- 3. Bernhard Schulte Shipmanagement (Singapore) Pte Ltd. may seek from the Court early termination of Probation, and the Govt. agrees not to object to such a request that is made after at least thirty-six (36) months, absent good cause.
- Bernhard Schulte Shipmanagement (Singapore) Pte Ltd. must operate in compliance with the environmental laws of the United States and may not violate the International Convention for the Prevention of Pollution from Ships.
